
ORDER:

In reference 1st cited Government have granted a Mining Lease in favour of Smt.Ravipati Suneetha for Quartzite over an extent of 28.00 Hects in Sy.No.1 of Sarayyavalasa Village, Dattirajeru Mandal, Vizianagaram District for a period of 20 years subject to provisions of Mines and Minerals (Development and Regulation) Act., 1957 and conditions laid down in Form-K prescribed under Mineral Concession Rules, 1960 and additional conditions stipulated in the Annexure appended to the grant order.

The grantee has furnished Security Deposit of Rs. 10,000/- in the shape of National Saving Certificate bearing No.78EE 086713 Dt.05-03-2007 at Deputy Post Master, Vizianagaram and submitted Guarantee Bond issued by the State Bank of India of Fort Branch, Vizianagaram vide Guarantee No.BG2/2006 which is valid up to 04-03-2008 under rule 23f (2) of M.C.D.R. Act, 1988 in favour of Assistant Director of Mines and Geology, Vizianagaram. The Mining Lease deed is executed in Form - K today i.e., on 05-03-2007.

Sanction is hereby accorded to Smt.Ravipati Suneetha for Quartzite over an extent of 28.00 Acs in Sy.No.1 of Sarayyavalasa Village, Dattirajeru Mandal, Vizianagaram District for a period of 20 years from 05-03-2007 to 04-03-2027 subject to the provisions contained in Mines and Minerals (Development and Regulation) Act., 1957 and conditions laid down in the lease deed in Form-K prescribed under Mineral Concession Rules, 1960.

The lessee should maintain all the records and accounts in the prescribed forms. The lessee should submit the monthly returns in prescribed forms to the Director of Mines and Geology, Hyderabad, Dy. Director of Mines and Geology, Visakhapatnam and Assistant Director of Mines and Geology, Vizianagaram and other prescribed officials within the stipulated period.
